

#### 8:30-9:30 Dialogue on Transformative Reparations

Many survivors expect reparations that can transform their living and life conditions and that could change the continuum of violence that allowed their violations to take place. How can reparations for survivors of conflict related sexual violence be used to generate meaningful transformations? What is necessary for reparations to be truly transformative? What is the relationship between transformative reparations and guarantees of non-repetition?

#### 11:10-12:30 Session 2 - Reparation for Conflict Related Forced Marriage and Related Forms of Violence

Research shows that survivors of forced marriage, sexual exploitation, and rape in conflict and post-conflict situations are in dire straits, and very little has occurred in terms of meeting their justice and reparation needs. Survivors of forced marriages have not received reparations that include transformative and restorative justice. This session considers what are the specific needs of survivors of forced marriage in war?
